**DAUNTSEYS SCHOOL REPORT TO WEST LAVINGTON PARISH COUNCIL  
MAY 2010**

Please find below a precis of the major current and future issues concerning the estate at Dauntseys School:

1. Girls Day House. Work continues on this, and it should be complete, as planned, by the end of June.
2. Cricket Pavilion. Refurbishment is almost complete.
3. Ornamental Gates. Planning permission for a pair of ornamental gates to be sited at the end of the main drive has been given.
4. Storage Facilities. Following the granting of planning permission, installation of these single-storey facilities will take place shortly.
5. 30 MPH Limit. The school would welcome any update on when the change to the Cheverell Road speed limit might become effective.
